

**ACME® Markets/Philadelphia Eagles SWOOP In and Win Sweepstakes  
and ACME® Markets/Philadelphia Eagles Kick Off Kid Sweepstakes  
Official Rules 2016**

ELIGIBILITY.** The ACME® Markets-Eagles SWOOP In and Win Sweepstakes (“SWOOP In and Win Sweepstakes”) and the Acme® Markets-Eagles Kick Off Kid Sweepstakes (“Kick Off Kid Sweepstakes”) (collectively, “Sweepstakes”) is open only to legal United States residents living in Pennsylvania, Delaware, Maryland and New Jersey who are 18 or older at the time of entry.
